- \_\_\_ Unemployment Insurance Claimant (**provide a printout of unemployment**)
- \_\_\_ Unemployed Adult (**provide a print out of past wages from DWS/NC Works Career Centers**)
- \_\_\_ Underemployed Adult (Individual) earning at or below 200% the federal poverty level (**W2 or most recent 1040 tax return**)
- \_\_\_ Military Veteran or spouse (**provide DD214 or DD2**)
- \_\_\_ Member of the NC National Guard (**Verification from Unit Commander**)

*Scholarship recipients may not be a Director, employee or family member of an employee of the State Employee's Credit Union or SECU Foundation.*

*Note: Preference will be given to students with limited or no access to financial aid from other programs.*
